The safety of exhibitors and buyers has always been a priority for the Hong Kong Trade Development Council (HKTDC). With the Compulsory Quarantine of Persons Arriving at Hong Kong from Foreign Places Regulation (https://www.elegislation.gov.hk/hk/cap599Elen?INDEX_CS=N) in place, overseas exhibitors and buyers would have great difficulty joining the HKTDC Hong Kong International Diamond, Gem & Pearl Show 2020 and the HKTDC Hong Kong International Jewellery Show 2020 on 18-21 May as originally scheduled. After consultation with the industry, the HKTDC will further reschedule the twin fairs to 3-6 August 2020 to be held at AsiaWorld-Expo.

Large-scale international exhibitions are important channels through which global jewellers can expand their business. To help industry players capture business opportunities during this difficult time, we launched a month-long Spring Virtual Expo @ hktdc.com (http://www.hktdc.com/virtualexpo) Sourcing on 1 April 2020, enabling global suppliers to maintain and establish contact with buyers during the traditional peak sourcing season. When the situation improves, the HKTDC will resume physical exhibitions as soon as possible to help global buyers and sellers recover the business lost during the pandemic. We will also provide O2O Business Connect business-matching service with video conferences for buyers who cannot attend the fairs.

We hope that the online promotion together with the physical exhibitions in August can complement each other and maximise synergy. Latest Fair Updates 23 March 2020

Due to the rapid development of the global COVID-19 outbreak, the Hong Kong SAR Government has gazetted the Compulsory Quarantine of Persons Arriving at Hong Kong from Foreign Places Regulation to protect public health. Starting from 19 March 2020, all travellers arriving from outside China must be quarantined upon arrival in Hong Kong for 14 days. The regulation will be in effect for three months until 18 June.

The new regulation means that overseas exhibitors and buyers planning to attend the HKTDC Hong Kong International Diamond, Gem & Pearl Show 2020 HKTDC Hong Kong International Jewellery Show 2020, which are currently scheduled to run concurrently from 18 to 21 May, will have great difficulty joinin In light of the changing situation, we have decided to suspend the preparation work for the twin fairs. At the same time, we are consulting with the industry to with other viable solutions. Details of any new arrangements will be announced in due course.

We would like to take this opportunity to express our gratitude to exhibitors, pavilion organisers, industry associations and buyers from around the world for their tremendous support for HKTDC events, especially some 2,000 exhibitors who had committed their participation with booths assigned before we halted processing the outstanding applications for the May shows. We will make every effort to provide the industry with the same safe and effective jewellery trading platform and continue helping companies capture business opportunities through multiple channels.
